(8) All the income and all the assets of the Trust shall be utilised in the manner and to the extent hereinafter provided for the charitable purposes including relief of the poor, education and medical relief and without prejudices to the generality of the foregoing, for the following objects, namely:

(a) to provide assistance by grants, donations or otherwise to poor or destitutes, orphans, widows and/or other persons deserving assistance in education, in medicine and help in any other manner either in cash or kind without any distinction of caste, race or creed.

(b) to establish, maintain, run, develop, improve, extend, grant donations for and to aid and assist in the establishment, maintenance, running, development, improvement, and extension of hospitals, clinics, convalescent homes, sanitarium, dispensaries, maternity homes and all similar institutions as will afford treatment, cure, recuperation and other allied advantages in the way of alleviating the pain and suffering of humanity and to give financial and other assistance to patients to get treatment in India and Foreign Countries;

(c) the establishment, running and maintenance of educational institutions of any kind for the benefit of the public without distinction of caste, race or creed;

(d) to establish, maintain, run, develop, improve, extend, grant donations for and to aid and assist in the establishment, maintenance, running, development, improvement and extension of all kinds of Educational Institutions of the general, technical, vocational, professional or of any other description whatsoever for the welfare and uplift of general public without distinction of caste, race or creed;

(e) to institute and award scholarships to Indian Citizens for Study, Research, Apprenticeship in India or to enable them to proceed to Foreign Countries for study;

(f) to establish, maintain, run, develop, improve, extend, grant donations for and to aid and assist in the establishment, maintenance, running, development, improvement and extension of Libraries, reading rooms, Recreation Centres, Bala Vihars and all other facilities as are calculated to be of use to the public.

(g) to print, publish in different languages, books magazines periodicals, book-lets, papers etc., in furtherance of the above object and acquire and run printing and/or publishing houses;

(h) to do all such acts in furtherance of the above purposes and in advancement of any other charitable object of general and public utility.

(9) The affairs of the Trust shall be managed by the Board of Trustees of the said trust. The Board of Trustees shall consist of not less than three and not more than nine Trustees as the Board of Trustees shall from time to time resolve, until otherwise resolved, by the members shall be three only. The quorum for transacting the business by the Board is the presence of Three Trustees.

(10) The Author and the other Trustees being parties to this indenture and every person who may hereafter be appointed as Trustee shall constitute the Board of Trustees and the word "Trustees" in these present except when the context so requires, shall include the Author of the Trust.

(11) There shall be appointed from among the Trustees the following Office Bearers namely :

(12) The First Trustees and Office Bearers:

1. Sri Chitturi Visweswara Rao, shall be the Managing Trustee of the Trust.
2. Srimathi Chitturi Sreerama Ratnam shall be the Chairman of the Trust.
3. Sri Chitturi Bala Siva Subrahmanyam shall be the founder trustee.
4. Sri Kommuri Veera Raju shall be the founder trustee.

(13) The Chairman of the Board shall, if present, preside over all the meetings of the Board of Trustees. If the Chairman is not present within half-an-hour of the time for which the meeting has been convened, the Trustees present shall elect one from the Body present at that meeting, to be the Chairman of the Meeting. The Author and the First Chairman of the Board shall hold Office for their life unless they resign.

(14) On any vacancy occurring in the Board of Trustees by the death or resignation of a Trustee or any other cause, it shall be competent and lawful for the remaining members of the Board to appoint any person or persons in the vacancy or vacancies. If the Board, by a resolution, resolves to increase the number of Trustees to more than three, the vacancy so created by such increase shall be filled up by appointment by the existing Trustees. The power of appointment of Trustees shall be exercised by a resolution by the Board of Trustees.

(16) Any vacancy in the office of the first Trustee of the Trust shall be filled in by the Board. In appointing such Trustees, the Board shall consider the suitability of the persons such as integrity, ability, culture, administrative capacity and charitable disposition and of their being in a position to devote to the affairs and the fulfilment of the objects of the

Trust. Further such Trustees shall be, as far as possible, from the family of Sri Chitturi Visweswara Rao (the family shall mean and include any descendant male or female in the male or female line of Sri Chitturi Visweswara Rao and his wife). The persons so appointed shall hold office of the Trustee of the Trust in succession for his life and in case of any successor being disqualified for the reasons stated in clause No.17 or retiring or resigning, the next in succession shall be appointed to take place of the Trustee. In the absence of any male descendant of the so appointed Trustee who dies or retires from Office or becomes disqualified in accordance with clause 17 hereof, then the Board may appoint another person in the place vacated by the Trustee.

(17) The Office of a Trustee or of an office bearer shall be vacated if the Trustee or Office Bearer -

- (a) is found to be of unsound mind by a court of competent jurisdiction;
- (b) is adjudicated insolvent;
- (c) is convicted of any offence involving moral turpitude.

(d) is expelled by the remaining Trustees of the Board by passing a resolution that his behaviour is detrimental and prejudicial to the objects and interests of the Trust.

(18) On Vacancy arising in the office of the Chairman or in the Office of the Managing Trustee, the successor to such office shall be elected by and from the Board of Trustees.

(19) The Board of Trustees shall be entitled to act and exercise all their powers notwithstanding any vacancy or vacancies in the Board, provided that the total number of Trustees shall not at any time be less than three. If the total number of Trustees shall be less than three, then the continuing members may act for the purpose of increasing the number of Trustees and to appoint Trustees for filling up any or all casual vacancies and not for any other purpose.

(20) The Board of Trustees may, at their absolute discretion, apply the funds of the Trust for any of the objects of the Trust either by directly carrying out the same or in conjunction or cooperation with any other person or body by way of contribution, subscription, endowment or other payments to any other Trust, Institution of Charity for carrying out any of the above objects and in particular by cooperation with any person, concern, institution or body whether charitable or not for the establishment of any Trust having as its objects one or more of the above objects of this Trust.

(21) All the properties, assets and funds of the Trust shall be vested in and be held in the name of the Board of Trustees and shall be held in such manner as the Board shall direct or in the name of one or more of the Trustees as the Board may deem fit.

(22) The Board of Trustees shall have full control of management of all the affairs of the Trust and of the properties, assets and transactions of the Trust and without prejudice to the generality of the foregoing provisions to exercise any or all of the following powers and discretions namely:

(a) to determine from time to time, to commence, to take up, to abandon, to vary and to add to the objects and purposes for which the funds of the Trust shall be used and to allocate and allot to each of the objects such portion of the funds as they deem fit.

(c) to acquire, purchase movable and immovable properties including rights therein, to sell or lease out or otherwise dispose off either in whole or any part thereof any or all movable or immovable properties.

(d) to invest or deal with all the moneys of the Trust in such securities, shares, stocks, debentures, fixed deposits by giving loans or otherwise and in such manner as may from time to time be determined and in accordance with the provisions of the Incometax Act.

(e) to borrow guarantee, raise or otherwise procure moneys or the security of movable, immovable or other assets of the Trust.

(f) to equip, furnish or otherwise conduct hospitals, nursing homes, sanitoria, maternity houses or other medical institutions or any premises necessary or useful for carrying out the objects of the Trust;

(g) to frame rules and bye-laws for the conduct of the business of the Trust and of its transactions and of the Committee of Management and to determine as to who shall be entitled to operate on the Bank Account or Accounts of the Trust and draw cheques thereon;

(h) to incur all expenditure necessary or in their opinion useful for carrying out any of the objects of the Trust;

(i) The Trustees may from time to time delegate any of the powers vested in them under these presents or the powers required by these presents to be exercised by the Managing Trustee or other Trustees by the Unanimous consent of the Trustees and may from time to time revoke or modify such powers so delegated. The Trustees may give some directions to the Managing Trustee in relation to the affairs of the Trust and the exercise of the powers by him as they deem fit and may from time to time vary or revoke the same;

(j) The Managing Trustee shall be in control and possession of all books, papers and documents of the Trust and shall be in control of all the day-to-day affairs of the Trust and all dealings and accounts and transactions thereof and shall have control over all the employees and servants of the Trust, and to institute, conduct or defend all suits and legal proceedings for and on behalf of the Trust and to receive service of summons and processes for and on behalf of the Trust and to sign pleadings, plaints, written statements, applications, affidavits and vakaltanamas for and on behalf of the Trust in respect of any suit or proceedings before any court of law or other authority and to engage a lawyer or lawyers for and on behalf of the Trust and to fix and pay remuneration to them.

with any of the provisions of this Trust and in either case such contribution shall be dealt with either as capital or as income according to the directions of the donors but subject to the condition that in the opinion of the Trustees it must be conducive to the beneficial administration of the Trust.

(24) It shall be lawful for the Trustees to carry out any of the objects of the Trust either directly, by themselves or by institutions run by the Trust and others jointly or in cooperation or by making contributions to or subsidising any institutions carrying out any similar objects or aims.

(25) The Trustees may act by a majority. The Trustees exercise all powers vested in them under these presents or by-law, by means of resolutions passed at the meetings of the Board of Trustees by a majority. Any resolution in writing circulated to all the Trustees holding office for the time being as such and agreed to in writing by a majority of them shall be valid and binding as if it has been passed at meetings. The Chairman of the Board of Trustees shall have, in the event of an equal division a casting vote in addition to his vote as Trustee. All acts done in pursuance of a resolution of the Trustees shall be valid and binding as if agreed to and done by all the Trustees.

(26) The Managing Trustee shall cause to be prepared and shall lay before the Trustees the annual accounts and statements of income and expenditure of the Trust made upto 31st March of every year within six months of the

close of the year of account. The Trustees shall appoint one or more chartered Accountants to audit the accounts of the Trust. The accounts of the Trust shall be audited every year. The Trustees shall fix and pay the annual remuneration for the audition. Every appointment of the Auditor shall be for one year at a time but the retiring auditors shall be eligible for reappointment.

(27) If necessary the Board may nominate one or more Trustees from them either by name or otherwise to be in custody of any of the assets of the Trust for and on behalf of the Trust and/or to execute all documents, contracts and deeds for and on behalf of the Trust.

(28) The Trust hereby created is irrevocable, but the Trustees may, by unanimous consent of all the Trustees for the time being, modify any of the provisions of this Trust deed other than clause 8 above, in such manner as they may deem fit and thereupon the terms of the Trust Deed so modified shall apply to and be in force as if the modified terms ~~are~~ contained in these presents.

(29) In the event of dissolution the assets remaining shall be transferred to any other institution with similar objects and aims which has been recognised by the Incometax Authorities as registered under Section 12 A of the Income-tax Act, 1961.

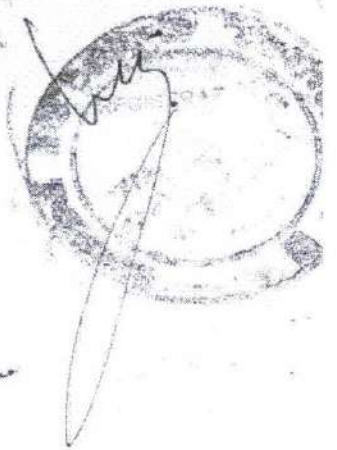

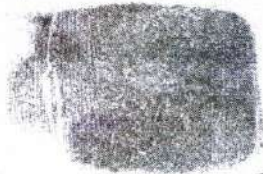

EXTRACT OF MINUTES OF MEETING OF M/S.SRI CHITTURI VISWESWARA RAO TRUST, VIJAYAWADA HELD ON DT. 03.09.1987 AT ITS REGISTERED OFFICE AT 14.8.14, NAGABHUSHANAM STREET, HANUMANPETA, VIJAYAWADA-3. UNDER THE CHAIRMAN SHIP OF SMT.CHITTURI SREE RAMA RATNAM MANAGING TRUSTEE.

APPOINTMENT OF SRI CHITTURI ANANDA RAMA SUDHAKAR AS TRUSTEE.

THE CHAIRMAN INFORMED THE TRUSTEES, SINCE THE BOARD DEEMED IT NECESSARY TO APPOINT SOME MORE TRUSTEES FOR THE DEVELOPMENT OF THE ACTIVITIES OF THE TRUST. 




